NSW Drug and alcohol authorised testing person identity card notification for Lost/stolen, damaged/illegible, and cancelled cards

Instructions

> Use this form to notify the ONRSR NSW Branch if a NSW issued drug and alcohol testing authorised person identity card is;

- ❖ **lost or stolen**
- ❖ **damaged or illegible**
- ❖ **cancelled**

Note: a separate process applies for NSW D&A authorised testing person identity cards that: *are due for renewal, or have expired*

> Complete your organisation's details in the table below and then provide the identity card details in the notification section on page 3.

> On receipt of the correctly completed form, the ONRSR NSW Branch will reissue or cancel identity cards as advised.

Important information

NSW Authorised persons are required to hold an identity card, issued by the NSW Branch of the Office of the National Rail Safety Regulator (ONRSR) that must be produced on request to any person subject to the directive power of the authorised person.

Lost or stolen cards

- > The NSW drug and alcohol identity card is an important legal document. You are responsible for advising the ONRSR (NSW Branch) if your card is **lost or stolen** by completing this form.
- > Lost or stolen cards will be cancelled and the card number will be marked as void.
- > If a new replacement card is required; when completing the form, ensure you tick **'yes'** for new card. It is important to note that the card bearer will be issued with a brand new card number.
- > Completion of lost/stolen declaration is also required (see page 4) for 'Declaration template'.

Damaged or illegible cards

- > If an identity card is **damaged or illegible** it is recommended that the card be replaced.

Cancelled cards

If a person to whom a NSW D&A ID card has been issued **ceases to be an authorised person**, (i.e. no longer appointed, or, no longer an employee), the RTO or the Third Party Service Provider must return the identity card to the ONRSR (NSW Branch) as soon as practicable. Failure to do so is an offence under the National Rail Safety Legislation.
